RE: Recreation Advocacy Groups Support for Emery County Public Land Management Act of 2018 (S. 2809/H.R. 5727)

Dear Senator Hatch and Representative Curtis,

Today the Outdoor Alliance, Access Fund, American Whitewater, The Conservation Alliance and Outdoor Industry Association write in support for your proposed Emery County Public Land Management Act of 2018. In our view, this proposal as it is currently written effectively balances important conservation protections with recreation management designations that will promote high quality recreation opportunities while also protecting and enhancing the regional economy. We also understand that this proposal enjoys widespread support from a broad range of user groups, conservation organizations, local governments, and the outdoor business community. As such, we applaud your efforts to develop a widely supported public lands protection bill for Emery County, Utah.

The Emery County Public Land Management Act of 2018 was developed by Emery County and a coalition of stakeholders, including conservation organizations, motorized recreation, human-powered recreation, local officials and governments, the State of Utah, the Congressional delegation, and many more. As recreation advocacy organizations, we particularly support key provisions in this bill that establish a Recreation Area to highlight and permanently protect the recreational resources and conservation values of the San Rafael Swell region. This bill would also designate 63 miles of Wild and Scenic River, protect existing rock climbing resources, study future trail development opportunities, and establish wilderness areas throughout Emery County, amounting to several hundreds of thousands of acres of permanent conservation in all.

We appreciate continuing efforts to resolve two issues that concern the outdoor recreation and conservation communities: additional wilderness protection and Utah SITLA land exchange. We understand that your offices have reached an agreement on the directed land exchange to not trade land into the Ute Indian reservation. Outdoor Alliance, Access Fund, American Whitewater, The Conservation Alliance and Outdoor Industry Association support this agreement and the directed land exchanges as outlined on the Utah Trust Lands acquisition target map dated November 28, 2018 (also see attached map that depicts the Emery County subset of directed land exchanges, page 4). We also support the proposal to expand the bill's wilderness area with designated wilderness additions that include Muddy Creek, Labyrinth Canyon, and other areas that are drawn to avoid impacts to important mountain bike trail resources (see attached map of proposed wilderness additions, page 4) that are highly valued by our community.

It is important that the many benefits and resources associated with Emery County be available for future generations, including diverse recreation and conservation values.
