## **Support for Protect America's Rock Climbing Act**

The undersigned organizations support the Protect America's Rock Climbing Act that will protect against unnecessarily restricting rock climbing, mountaineering, and backcountry skiing opportunities in America's wilderness areas.

Federal land management agencies manage approximately 60% of America's climbing areas which totals approximately 20,000 discrete cliffs, boulders and alpine objectives inside and outside of designated wilderness. This collection of American climbing areas represents some of the best climbing in the world and has provided inspiration for generations of American conservationists.

Currently the National Park Service (NPS) and U.S. Forest Service (USFS) are considering new and unprecedented land management policies that would consider fixed anchors as prohibited "installations" under the Wilderness Act. Climbing fixed anchors are critical tools for navigating technical terrain in wilderness and are essential for rock climbing, mountaineering and backcountry skiing in some of America's most iconic public lands, such as El Capitan in Yosemite National Park, Long's Peak in Rocky Mountain National Park, and Wyoming's Wind River Mountains.

A national prohibition on fixed anchors in wilderness would jeopardize the safety of climbers, harm our recreation economy (rock climbing is a \$12 billion industry according to the Outdoor Industry Association), contradict the purposes of the Wilderness Act, waste taxpayer dollars, and restrict access to some of the wildest places in America. If the NPS and USFS implemented this new interpretation of the Wilderness Act, the federal land agencies will be overwhelmed with having to make site-specific decisions for every existing fixed anchor in wilderness, potentially erasing critical pieces of American climbing history because the federal government has allowed the conditional use of fixed anchors since the 1930s.

Importantly, this proposed new prohibition on fixed anchors is unnecessary because USFS and NPS already have the management tools—supported by the climbing community—to effectively regulate climbing and protect wilderness character. Federal land agencies have developed national-level policy to manage fixed anchors in wilderness without making the legal conclusion that fixed anchors are banned "installations" under the Wilderness Act. Also, outfitters, guides, recreation-dependent gateway communities, and recreational climbers will all have to deal with unprecedented uncertainty as to whether or not longstanding fixed anchors will be maintained and available for continued use. This uncertainty will have adverse impacts on small businesses and the outdoor recreation economy at a time when many policy makers around the country are looking to promote rural economic development.

Protect America's Rock Climbing Act will establish consistency between federal agencies and support sustainable wilderness management by making clear that climbing and the use, placement, and replacement of climbing anchors are an "allowable activity" within America's wilderness areas, subject to reasonable rules and regulations to protect wilderness character.

Climbers deeply appreciate wilderness and support restrictions that protect wilderness resources and character. But this new interpretation of the Wilderness Act would overturn nearly

60 years of precedent and create a new presumption of illegality that sends a strong signal to climbers and other human-powered recreationists that they are no longer welcome in America's wilderness areas. Recreation and conservation organizations have historically worked in partnership to establish some of our most significant conservation gains such as the Great American Outdoors Act, and the John D. Dingell Jr. Conservation, Management, and Recreation Act. Establishing a dangerous policy that makes climbers and mountaineers unwelcome in wilderness will damage critical relationships and weaken support for conservation and public lands.

For the aforementioned reasons, the following signatories support the Protect America's Rock Climbing Act to preserve the unique world-class wilderness climbing opportunities found only on America's public lands.
